## How to Use This Report

This sample report contains a short listing of typical projects found in the full version of the **Future Projects Report**. They are ordered by State and Bid Date. It is anticipated that the full quarterly report will contain two to three hundred projects in the over \$25 million range.

The **Futures Projects Report** is a flexible tool that has been designed to be useful to our customers in a variety of formats. It is available as a PDF file that can be viewed over the Internet through a secure portal or this same file can be downloaded for use on your personal computer. In addition, the file can be downloaded as an Excel spreadsheet and managed in that format as you see fit.

The following descriptions will serve useful in understanding the content in each of the data fields:

- **State** - the state in which the project is located
- **Bid Date** - the projected bid date (sometimes referred to as the advertisement or let date)
- **Cost** - the estimated construction cost in millions of dollars
- **ID number** - A unique number assigned by the state to the project. Useful when tracking changes and seeking further information from a Project Manager
- **Project Name** - often the state will create a short name or description that becomes the "shorthand" means by which project personnel refer to the project
- **Project Manager and Contact Information** - The individual who is responsible for getting the project to bid. Usually different from the Resident Engineer or Project Engineer who will oversee construction. The phone number is either for the PM or the best number available for additional information
- **Project Comments** - unique insights, specific observations or other useful information for additional background or context on the project
